

Dear EHS Student:

If you plan to take Dual Credit classes this summer or fall, please read:

TSI testing requirements and college registration for 21-22 dual credit are due by **4/30/21**.  
*Note: it takes 7-10 business days for the online application to Navarro to be processed. So, you can't wait until the last minute to apply.* Be sure to include your Social Security number on the college application. For anyone who don't have a social security number, please see your EHS counselor to pick up a form that must be notarized after you have applied to the college.

## How to Register for Dual Credit

### NEW Dual Credit Students

1. Review the registration steps found [HERE](#).
2. Go to [www.ApplyTexas.org](http://www.ApplyTexas.org) and complete a college application to Navarro College.  
(**use an email you check often!**)
3. **\*\*Be sure to include your Social Security number on the Navarro College application.\*\***
  1. If you don't have a SS#, let your EHS Counselor know that you have applied to the college, so we can make sure they find your application.
4. Wait 7-10 business days for your welcome email from Navarro. (you can apply for the Brilliance Scholarship while you wait or after you are accepted to the college)
5. Using info found in your welcome email, you can login to the Navarro College portal on the <http://www.NavarroCollege.org> website and complete the *Permit to Register* form.
6. Your parent will then get an email and must electronically sign a consent form for dual credit.
7. Apply for the Brilliance Scholarship by **5/30/21** using the VERY EASY and SHORT online application found [HERE](#).

### RETURNING Dual Credit Students

1. Review the registration steps found [HERE](#).
2. Login to your Navarro College portal and proceed to complete the online *Permit to Register* form.
3. Apply for the Brilliance Scholarship by **5/30/21** using the VERY EASY and SHORT online application found [HERE](#).

College tuition payment details will be emailed to you later, after you are registered by the college.
